

# China Waiting Child Adoption Program

MAPS provides you with the support and guidance you need throughout this journey, as we strive to bring you and your child together as quickly as possible.

## THE CHILDREN

The children listed on the CCAA Waiting Child database range in age from 8 months to 13 years of age. There are both male and female. These are children that are currently available for adoption and have been placed on the list because they either have moderate to severe special needs and/or are older (7-13 years).

Special needs commonly seen in children on this list: Cleft lip/palate, congenital heart disease, vision or hearing issues, club foot/feet, extra digits, hepatitis B, lazy eye, limb deformity, heart murmur, etc.

There are occasionally children who have already had correctible surgery for a special need and may only need follow-up care.

The general issues relative to children who have been institutionalized may apply; however, many of these children reside in foster care. The health care and stimulation in the orphanages is adequate, although lack of resources limit what can be done. Healing from neglect and poor nutrition is a reality for some children who enter the orphanage from inadequate home conditions. The children in this program may or may not have any documented social or medical history prior to arrival in the orphanage. Social histories consist of a statement, usually stating where the child was found. Medical records consist of brief examinations, laboratory test results and a developmental report.

Families who will be adopting older children must be aware that these children have likely suffered some institutional and/or emotional deprivation during their early years of life. The children we have assisted appear to be well cared for by warm, concerned caretakers. However, characteristics of these children may be similar to those of any child with special needs stemming from lack of proper parenting; a loss of personal history and genetic connection; multiple caregivers; and the developmental delays that often result from institutional care.

MAPS recommends that adoptive families make every effort to understand the issues of adoption from their child's point of view. Since adoption issues do not end with placement, it is suggested that adoptive families remain open to support from a variety of resources as their child grows into adulthood. These resources include adoptive parent groups, the home study agency, professional counseling, and an ever expanding body of literature on adoptive parenting. MAPS is always available to help parents with such resources.

## FAMILY REQUIREMENTS

(All of the requirements of the China Program apply)

**Age** - applicants must be at least 30 years old but no older than 50 at the time of dossier submission to the China Center of Adoption Affairs (CCAA).

The CCAA generally assigns children approximately 10-12 months of age to applicants where the younger parent is under 45. If the applicants are 46-49, they will be assigned a child of 1-3 years. Applicants cannot be older than 50. Couples who are 50-55 may adopt a waiting child only. Exceptions to these requirements may be granted by the CCAA when adopting special-needs children or children over age 6.

Applicants can only adopt one child at a time from China. The adoption of twins is extremely rare and involves a long wait with no guarantee. Applicants who have already adopted a child from China, and would like to adopt a subsequent child, must wait until their 12 month post-placement report has been submitted to the CCAA before submitting their dossier for a subsequent child.

**Family Size** - families may have no more than 4 children under age 18 living in the home, and the youngest must be at least 1 year old.

**Marital Status** - single applicants are no longer eligible. Couples must be married at least 2 years. If either spouse has been divorced, they

must be married at least 5 years. No more than 2 divorces per spouse permitted.

**Health** – both applicants must be in excellent health mentally and physically, including a BMI (body mass index) of 40 or less. All health issues will be reviewed on a case by case basis. Please consult with MAPS regarding health requirements.

**Income** – one applicant must hold a stable occupation, \$10K minimum income per family member (including child to be adopted). Family's net worth should be at least \$80,000 (assets vs. liabilities).

**Education** – both spouses must have at least a high school degree.

**Criminal Record** – any criminal charges will be reviewed on a case by case basis.

**Religion** - couples with religious beliefs that prevent any sort of medical treatment, including blood transfusions, for the child, will not be eligible to adopt from China. This also includes religions that use alternatives to blood transfusions, as this is not available in every country.

**Rehabilitation and Nurture Plan** – families must be able to demonstrate that they are aware of the implications of the health issues of the child they accept and that they have the commitment and ability to meet the child's needs, e.g., access to medical professionals, financial means, coordination of ongoing medical treatment or therapy, etc.

## TRAVEL REQUIREMENTS

One or both parents must travel. MAPS coordinates all travel and accommodations to and within China. Length of stay is approximately 2 weeks (possibly 3 weeks if child is from Guangdong Province).

When you travel, you will be accompanied by our bilingual Chinese representative for your entire stay in China and be in the best of hands.

## TIMEFRAME & PROCESS

Once your family has been accepted into the China Waiting Child program, your MAPS program coordinator will carefully monitor the database to locate a child that appears to meet your preferences regarding age range, gender and special need(s). When you have accepted a child referral, we will guide you through the next steps, which will involve creating your letter of intent and completion of your dossier (if not already submitted), according to the rules of the CCAA.

The timeframe for identifying a child from the CCAA's database is extremely variable. Families are encouraged to explore their openness to either gender, their ability to welcome a child into their family who may be toddler or school aged, and to investigate the range of health conditions that they would be willing to accept. On average, it appears that the typical timeframe for processing, once all of the CCAA's paperwork requirements have been fulfilled for an identified child, could be 4-6 months.

MAPS staff, here and in China, work with the Chinese central and local governments on pre-adoption steps that must be completed prior to travel. In addition, MAPS will assist you in obtaining visas to enter the country.

The administrative processing of the actual adoption occurs while the family is in China. Child and family travel can take place as soon as U.S. immigration and visa procedures are completed in Guangzhou.

Before you return home, China will issue your family a final decree of adoption of your child. After your child arrives home, there is a post-placement supervisory period and finalization in the court of the family's state of residence. Families are required to send periodic reports and photographs, through MAPS, until one year from the date of placement.

Please be aware that programs of international adoption are always evolving on the foreign side. During the course of your adoption, you may encounter some policy and procedural changes, delays, administrative backlog, and restrictions or moratoriums placed on the program by the foreign government. We will keep you advised of any changes and will work diligently to bring you and your child together as soon as possible.

## **COSTS**

The initial fee submitted to MAPS, with your application, is the application fee of \$600 and is not country-specific. MAPS Agency fee for China is \$6,300 (payable upon acceptance into program) and the Foreign Program fee for China is \$4,750 (payable within 10 days of child acceptance). This includes MAPS costs both in the U.S. and China and is due upon child assignment. Additionally there is a \$1,640 dossier submission fee which covers the costs of translation and the CCAA service fee. The above fees do not include the mandatory orphanage donation of \$35,000 RMB (depending upon the exchange rate, approx. \$5,300 USD). For more information, please refer to the fee schedule for possible additional costs.

## **GETTING STARTED**

The adoption process begins with the application packet. In this information we walk you through the materials needed to open your file. Your application to MAPS should be submitted as soon as possible, whether or not your home study is completed. Your home study must be done by a licensed adoption agency in your state. We cannot accept studies done by licensed independent social workers and probate courts. We will formally accept your completed file after full review of your home study and related application materials.

Your home study is valid for approximately one year (varies by state). If placement has not occurred within that time, you will need your home study agency to provide MAPS with an original, notarized update. We recommend that you determine the fee for this service up front so that you may be prepared if the process takes longer than expected.

MAPS will also need one photocopy of your CIS I-800A approval/cable notice. If not yet received, file your I-800A immediately and state that you would like the approval notice cabled to the American Consulate in Guangzhou, China. You should file your I-800A with CIS early in your home study process.

## **HUMANITARIAN AID**

An important component of our China adoption program is humanitarian aid. MAPS supports the foster care of several Chinese children annually, through collaboration with Love Without Borders. Additionally, we encourage our placed families to participate at whatever level they can offer to help support the children who remain behind. We are proud that our families continue to care and put forth efforts on behalf of the children and orphanages of China. Their selfless efforts have made a difference to these children.

<b>FEE SCHEDULE FOR ADOPTIONS FROM CHINA</b>

MAPS application fee (due with application)	\$600
MAPS agency fee (payable at program acceptance)	\$6,300
MAPS foreign program fee (payable at child acceptance)	\$4,750
Additional fee for twin adopted at the same time \$2,000 (\$1,000 for stateside adoption program expenses/services, \$1,000 for in-country adoption program expenses/services).	

**ADDITIONAL COSTS**

These are some of the possible additional expenses that you can anticipate. They may vary on a case-by-case basis.

Travel for child/ren	Approx. \$150-\$1,300 per child
Visa medical exam	Approx. \$65 per child + any lab work
Child's U.S. visa (per child)	\$400 (Due at child acceptance for I-800A cases)
Lodging, food, necessities (parents, child/ren)	Approx. \$1,500-\$2,000 depending on accommodation
Miscellaneous fee for orphanage banquet, ground transport (incl. most sightseeing)	Approx. \$500
